

The defendant, Samuel H Borntreger, in violation of Section 565.020, RSMo, committed the class A felony of murder in the first degree punishable upon conviction under Section 565.020, RSMo, in that on or about November 1, 2006, in the County of Harrison, State of Missouri, the defendant after deliberation, knowingly caused the death of Anna Yoder Borntreger by giving Anna Yoder Borntreger antifreeze and battery acid.

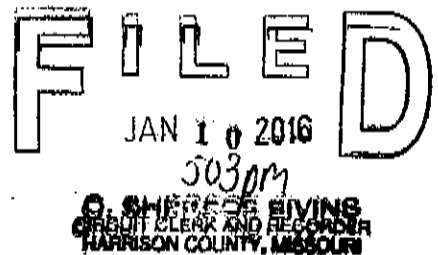


