On the 15 day of November, 2021 at 00:00 (Specifically include facts constituting cause for arrest.)

On November 15, 2021, at 6:40 pm the victim, 14-year-old [REDACTED] left his home on his bike in Palm Beach Gardens, Palm Beach County, Florida.

On this same date at 10:30 pm, the victim's mother reported him missing as he had not returned home. Palm Beach Gardens Police Department initiated an investigation of the missing juvenile.

On November 16, 2021, the victim was found deceased on Central Boulevard, 80 feet south from the Interstate 95 overpass. The estimated address is 12284 Block of Central Boulevard, Palm Beach Gardens, Palm Beach County, Florida. The body was found in a wooded area, out of plain sight, approximately 24 feet from the sidewalk.



Your affiant, was assigned the lead investigator. The investigation revealed the victim was traveling south on the east sidewalk of Central Boulevard. At approximately 7:30pm the victim was on the Interstate 95 overpass traveling south. Data recovered from the victim's phone revealed he stopped traveling at approximately 7:31pm.

Video Surveillance showed a single individual walking Northbound on Central Blvd also on the Eastside sidewalk at 7:20pm. The subject was walking toward the victim. The two would have crossed paths at approximately 7:31pm.

An autopsy revealed the victim was stabbed numerous times in the head and face. The cause of death was stab wounds, and the manner was a homicide.

A set of headphones was collected at the scene. The investigation revealed that these did not belong to the victim. The Palm Beach County Forensic Biology Unit (PBSO FBU) identified a DNA source from submitted swabs obtained from the headphones. The DNA Sample was entered into the Combined DNA Index System (CODIS) database which produced a

A lawful search warrant was obtained for the backpack, and it was searched. Inside the backpack investigators discovered a bandana that appeared to be bloodstained. An analysis was completed by PBSO FBU, and the stain was confirmed to be blood. The analysis further showed that the sole two contributors to the DNA mixture from the blood on the bandana, are [REDACTED] and Semmie Lee Williams.</p> <p>On November 26, 2021 Semmie Lee Williams Jr was interviewed post Miranda, the suspect denied any interaction with the victim. Semmie Lee Williams Jr was located in Miami but there is evidence to show he traveled to Palm Beach County, Florida on November 15, 2021, and returned to Miami, FL on November 16, 2021.</p> <p>Due to the above articulated facts, I believe there is probable cause to arrest Semmie Lee Williams Jr. for the crime of First (1st) Degree Murder with a weapon contrary to Florida State Statute sections 782.04 (1) (a) 1 & 2 and 775.087(1).</p>
